SECTION C SCOPE OF SERVICES

Financial and Systems Consultant Services

INFORMATION AND BACKGROUND:

"HOME" is an affordable housing and community development parent company that serves as largest provider of affordable multi-family housing in El Paso, Texas.

HOME is comprised of a number of related and subsidiary companies, starting with the Housing Authority of the City of El Paso (HACEP), a Texas municipal housing authority, and a number of affiliates that perform the various functions relating to the ownership, development, financing, and property management of housing and related real estate.

HOME and its affiliates each have dedicated business line staff as appropriate with support services such as Finance, Human Resources, and Information Technology provided as outsourced functions to all of the companies. HOME has a full-time staff of approximately 230 employees, and a \$100 million operating budget and supervises assets of over \$165 million.

HOME is one of the most successful and best-regarded community development corporations in the nation. Through its flagship, HACEP, and acting in conjunction with its affiliated entities, HOME has been the major catalyst for affordable housing and the physical and economic renaissance of El Paso, Texas for 80 years. In addition to developing residential properties, HACEP purchases existing properties including apartments ending tax credit compliance and market rate units that can help serve both market rate and low-income residents.

HOME's key affiliates are:

Paisano Housing Redevelopment Corp, a Texas nonprofit public facility corporation and registered 501(3)(3) organization, owns properties and serves as a co-developer with other multi-family developers in a number of development deals, has self-developed residential properties, and is currently orchestrating the largest HUD RAD conversion in the United States utilizing Tax Credits, private equity, public bonds, and other funding sources. Through the RAD conversion, HOME's largest residential portfolio, formerly public housing, will be converted to PBRA (project based rental assistance) and PBV (project-based vouchers).

Alamito Public Facilities Corporation is a nonprofit "public facility corporation" affiliate that finances and issues bonds to provide for the acquisition, construction, rehabilitation, renovation, repair, equipping, furnishing, and placement in service of real estate. Alamito PFC primarily acts through allocations of private activity bonds with the Texas Bond Review Board and as the issuer of the resulting bonds.

EP Housing Operations & Management Enterprises PFC (EP HOME), a public facilities corporation, is the property management arm for HACEP and its affiliates, with a successful track record of providing over 20,000 residents with quality affordable housing and support services while working community wide to improve the quality of life. EP HOME currently manages and operates 65 properties, including 42 multi-family properties with a total of 8,322 rental units, valued at approximately \$126 million. Currently 6,100 units are undergoing major rehabilitation or redevelopment work of over \$1.2 billion through the federal RAD program. EP HOME also oversees community programming in the areas of arts and culture, youth development, health equity and community wellness, grassroots leadership development and civic engagement.

In addition to the above companies, there are various other single focused subsidiary nonprofits along with many partnerships and managing member organizations.

Financial and Systems Consultant Services

Scope of Services:

Selected individual will provide the services of an experienced Financial and Systems Consultant to support HACEP's CEO and the Chief Operating Officer (COO), and other staff members and key partners to develop and implement HOME's business plan in order to meet its strategic goals. The Financial and Systems consultant will support the financial strategy for reaching HOME's goals, support the Yardi system implementation, as well as monitoring and analyzing financial results. Interested prospective individuals must demonstrate previous work experience in the areas described herein, preferably in Public Housing Authorities, similar to HACEP and its Rental Assistance Demonstration ("RAD") environment.

Minimum Financial and Systems Consultant Job Requirements:

- Must have a bachelor's degree in Finance or Accounting from an accredited university is required. A Master's degree is highly preferred.
- CPA certification is highly preferred.
- Must have at least 10 years of demonstrated relevant finance and accounting experience.
- Direct working experience with LIHTC, PBRA, and PBV programs, or similar housing programs, is required.
- Direct working experience with 9% credits and 4% credits and bonds is required.
- Direct working experience with Historic and New Market Tax Credits, is a plus.
- Must have at least seven years of supervisory experience.
- Must be familiar with Corporate, Non-Profit, and Partnership tax filings.
- Must have at least five years' experience as a CFO or Director of Finance, with both technical
 and management proficiency in operations of a real estate development or multi-family
 organization.
- Must have knowledge and direct work experience with real estate accounting and finance, preferably in affordable multi-family housing.
- Must have a collaborative nature and facilitative approach, as well as the flexibility to work with broad range of cultures, personalities, and work styles.
- Must be committed to community development and helping low income communities.
- Must have excellent communications skills, both oral and written.
- Must have a strong work ethic.
- Must have a professional demeanor.
- Must have a strong willingness to cooperatively participate on a team within a mission-based organization.
- Must be able to work in a high-volume, fast-paced environment and be able to accommodate frequent priority changes to meet the needs of HOME's internal and external customers.
- Must be able to meet strict deadlines as it pertains to financial and related reporting, as well as all other assigned deadlines.
- Must have demonstrated experience with design and implementation of enhanced financial systems and procedures.
- Must have demonstrated ability to prepare clear, accurate, well-organized written and financial reports and to communicate verbally in an effective and concise manner.
- Must be highly proficient in Microsoft Office, accounting software programs, (preferably YARDI, Great Planes), system implementation and network administration.

Duties and Responsibilities:

Together with the CEO and executive leadership team, develops the strategy to ensure that the
organization has the financial resources needed to achieve its current and future goals, while
mitigating financial and operational risk.

- Serves as a key advisor to the CEO.
- Provides leadership and is accountable for the Agency's finance, audit and investment functional areas.
- Performs supervisory functions, including the following:
 - Provides employee training as needed;
 - Schedules employee work hours;
 - Monitors work activities;
 - Completes new hire, transfer and/or annual employee evaluations;
 - Provides employee development, counseling and disciplinary action as needed;
 - Responsible for handling employee complaints and grievances as appropriate; and
 - Participates in the department's recruiting efforts, including interviewing candidates and making hiring recommendations for open positions within the department.
- Develops and maintains effective working relationships with key financial partners including funders, investors, partners, government agencies, consultants, and vendors.
- Works with various entities as they monitor operating performance and compliance of the Agency's affordable housing and commercial portfolio, along with loan conversions and refinancing activities.
- Reports financial information to the Board of Directors, investors, lenders, and compliance/oversight agencies.
- Oversees organizational budgeting, accounting and cash management to ensure accurate reporting, interpretation and analysis of financial results in conjunction with forecasts and long-range plans.
- Manages and supports the preparation of the annual consolidated corporate financial statements and supplemental filings, audit and tax returns.
- Prepares the annual corporate consolidated financial statements.
- Oversees and reviews 65+ property audits and 75+ tax returns, along with the nonprofit audits and tax returns prepared by professional services firm.
- Establishes and maintains controls to safeguard assets, documents and recommends improvements to internal financial policies and procedures.
- Develops and completes timely financial statements, as well as reports on transactions and/or information requests.
- Develops key metrics and analysis of financial statements.
- Manages and monitors the organization's cash flow and real estate development capital needs.
- Optimizes the investment funds in accordance with the Agency's Investment Policy.
- Responsible for the day-to-day operations of the Finance department.
- Ensures that the Finance staff completes tasks on a timely basis, including, but not limited to, month/year end close, accounts receivable & payable, financial reports, payroll, invoicing, cash receipts and disbursements.
- Maintains various liability and insurance policies.
- Works collaboratively with Construction and Development staff to review potential acquisitions, debt, equity and public subsidy proposals and partnership/operating agreements.
- Reviews key legal agreements, including mortgages, loan documents, subordination agreement and guarantees as part of a financing and construction loan closing that may involve Low Income Housing Tax Credits, Historic Tax Credits, New Markets Tax Credits, bond financing, public subsidies and contracts, and/or private debt.
- In conjunction with the real estate development staff and auditors, ensures that the accounting for development and construction, equity draws, project cost certifications, and other specialized reporting to investors and government agencies are completed accurately and timely.
- Works with several Low-Income Tax Credit investors and lenders as they monitor operating

- performance and compliance of the Agency's affordable housing and commercial portfolio.
- Supervises Asset Manager(s) who oversee the operations of 8,300+ units of affordable rental housing, commercial properties and any third-party property management firms.
- Attends all HOME Board of Commissioners, and the Board of Directors meetings for the subsidiary/affiliated companies.
- Coordinates activities of the Finance/Audit and Investment committees including developing
 agendas and providing reports on financial investment and organizational performance and
 projections and other information to committee members in a well-organized, accurate and
 timely fashion.

- (e) Any disputes with regard to this clause are expressly made subject to the terms of clause titled Disputes herein.

4. Examination and Retention of Contractor's Records

(a) The HA, HUD, or Comptroller General of the United States, or any of their duly authorized representatives shall, until 3 years after final payment under this contract, have access to and the right to examine any of the Contractor's directly pertinent books, documents, papers, or other records involving transactions related to this contract for the purpose of making audit, examination, excerpts, and transcriptions.

- (f) The Contractor shall comply with Executive Order 11248, as amended, and the rules, regulations, and orders of the Secretary of Labor.
- (g) The Contractor shall furnish all information and reports required by Executive Order 11246, as amended and by rules, regulations, and orders of the Secretary of Labor, or pursuant thereto. The Contractor shall permit access to its books, records, and accounts by the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.
- (h) In the event of a determination that the Contractor is not in compliance with this clause or any rule, regulation, or order of the Secretary of Labor, this contract may be canceled, terminated, or suspended in whole or in part, and the Contractor may be declared ineligible for further Government contracts, or federally assisted construction contracts under the procedures authorized in Executive Order 11246, as amended. In addition, sanctions may be imposed and remedies invoked against the Contractor as provided in Executive Order 11246, as amended, the rules, regulations, and orders of the Secretary of Labor, or as otherwise provided by law.
- (i) The Contractor shall include the terms and conditions of this clause in every subcontract or purchase order unless exempted by the rules, regulations, or orders of the Secretary of Labor issued under Executive Order 11248, as amended, so that these terms and conditions will be binding upon each subcontractor or vendor. The Contractor shall take such action with respect to any subcontractor or purchase order as the Secretary of Housing and Urban Development or the Secretary of Labor may direct as a means of enforcing such provisions, including sanctions for noncompliance; provided that if the

Contractor becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction, the Contractor may request the United States to enter into the litigation to protect the interests of the United States.

17. Dissemination or Disclosure of Information

No information or material shall be disseminated or disclosed to the general public, the news media, or any person or organization without prior express written approval by the HA.

18. Contractor's Status

It is understood that the Contractor is an independent contractor and is not to be considered an employee of the HA, or assume any right, privilege or duties of an employee, and shall save harmless the HA and its employees from claims suits, actions and costs of every description resulting from the Contractor's activities on behalf of the HA in connection with this Agreement.

19 Other Contractors

HA may undertake or award other contracts for additional work at or near the site(s) of the work under this contract. The contractor shall fully cooperate with the other contractors and with HA and HUD employees and shall carefully adapt scheduling and performing the work under this contract to accommodate the additional work, heeding any direction that may be provided by the Contracting Officer. The contractor shall not commit or permit any act that will interfere with the performance of work by any other contractor or HA employee.

20. Liens

The Contractor is prohibited from placing a lien on HA's property. This prohibition shall apply to all subcontractors.

- 21. Training and Employment Opportunities for Residents in the Project Area (Section 3, HUD Act of 1988; 24 CFR 135)
- (a) The work to be performed under this contract is subject to the requirements of section 3 of the Housing and Urban Development Act of 1968, as amended, 12 U.S.C. 1701u (section 3). The purpose of section 3 is to ensure that employment and other economic opportunities generated by HUD assistance or HUDassisted projects covered by section 3, shall, to the greatest extent feasible, be directed to low- and very low-income persons, particularly persons who are recipients of HUD assistance for housing.
- (b) The parties to this contract agree to comply with HUD's regulations in 24 CFR Part 135, which implement section 3. As evidenced by their execution of this contract, the parties to this contract certify that they are under no contractual or other impediment that would prevent them from complying with the Part 135 regulations.
- (c) The contractor agrees to send to each labor organization or representative of workers with which the contractor has a collective bargaining agreement or other understanding, if any, a notice advising the labor organization or workers' representative of the contractor's commitments under this section 3 clause, and will post copies of the notice in conspicuous places at the work site where both employees and applicants for training and employment positions can see the notice. The notice shall describe the section 3 preference, shall set forth minimum number and job titles subject to hire, availability of

- apprenticeship and training positions, the qualifications for each; and the name and location of the person(s) taking applications for each of the positions; and the anticipated date the work shall begin.
- (d) The contractor agrees to include this section 3 clause in every subcontract subject to compliance with regulations in 24 CFR Part 135, and agrees to take appropriate action, as provided in an applicable provision of the subcontract or in this section 3 clause, upon a finding that the subcontractor is in violation of the regulations in 24 CFR Part 135. The contractor will not subcontract with any subcontractor where the contractor has notice or knowledge that the subcontractor has been found in violation of the regulations in 24 CFR Part 135.

Order of providing preference:

(The ability to perform successfully under the terms and conditions of the proposed contract is required of all Contractors and subcontractors subject to the procurement standards The procurement standards of 24 CFR 85.36 has been removed and replaced with (2 CFR 200.318(h).)This regulation requires consideration of, among other factors, the potential Contractor's record in complying with public policy requirements. Section 3 compliance is a matter properly considered as part of this determination.





The following categories define HACEP expectations for Contractor travel and meal expenses. Proper documentation must be submitted with the Contractor invoice before HACEP will consider reimbursement of travel or meal expenses. Such documentation must include detailed receipts for all requested amounts and the valid business reason for the expense. In addition, where HACEP management approval is required prior to reimbursement, Contractor must submit a memo detailing management's approval or the signature of the appropriate HACEP management representative on the detailed receipt. HACEP reserves the right to request additional information when assessing payment and may refuse or limit payment based on the documentation, or lack thereof, provided.

- Airfare Airfare is reimbursed at commercial Coach Class using lowest logical airfare and advance
