RE: Request for Quotes – Flooring Replacement at East Lake Club Apartments

The Pinellas County Housing Authority (PCHA) is accepting quotes from qualified companies to remove and replace carpeting, padding, and sheet vinyl regularly during unit turns for one year at 150 Eastlake Club Drive Oldsmar, Florida 34677.

SCOPE OF WORK

- Carpet, Padding, and Sheet Vinyl shall be kept in stock at company location for immediate unit turns and installation, as needed.
 - Must be installed within 48 hours of request.
- Carpet: Shaw's Eco Elegance, 100% continuous filament nylon with R2X stain guard, or approved equal. Color: Mink 720, or approved equal.
- Pad: 3/8" 5lb FHA cost to be broken down in square yards when submitting quote.
- Sheet Vinyl: Mohawk: Scottsdale Golden Rye 564, or approved equal.
- Carpet/padding and sheet vinyl labor cost to be broken down in square yards when submitting quote.
- Company shall itemize pricing for carpet, padding, and vinyl for one, two and three bedroom apartments (unit breakdown below). Invoicing shall be based on installed square yardage per unit needs.
- Apartment sizes with approximate installation figures are as follows:
 - 1BR/1BA 756 square feet (59.67 YD Carpet and/or padding/18.67 YD Vinyl)
 - o 2BR/1.5BA 1,072 square feet (85.33 YD Carpet and/or padding/30.16 YD Vinyl)
 - 2BR/2BA 1,108 square feet (98.67 YD Carpet and/or padding/19.83 YD Vinyl)
 - 3BR/2BA 1,283 square feet (105.66 YD Carpet and/or padding/23.83 YD Vinyl)
- Additional line item pricing shall be listed to include: metal, vinyl scrape up, appliance move, floor prep, skim coat vinyl, stairs, tack strip, furniture moving, repairs and minimum charge requirements. Contractor shall be responsible hauling all debris from property; no onsite dumping.

- Pricing shall be fixed for one year. Invoicing is based on installed square yardage per unit needs.
- Contractor to provide all labor, equipment, and material for above mentioned services.
- If proposing an 'approved equal', please provide specifications with your quote.
- Provide current Certificate of Liability Insurance and Workers Compensation Coverage with your quote.
