SCOPE OF WORK

- The Contractor shall provide the Jacksonville Housing Authority with their General Foreman's, or other appropriate Single Point of Contact (SPOC), name, and cell phone number. General Foreman or SPOC shall be on-call during the hours of operation
- This project is for the pruning and de-booting of (all) palm trees on properties.
- All tree pruning shall comply with the good arboreal practice for the particular species of trees and shall be
 consistent with the pruning standards and best management practices as adopted by the International Society of
 Arboriculture. Pruning Palm Trees Palm tree pruning shall consist of the removal of loose dead fronds, fruit
 clusters, and other vegetation from all palms.
- The use of climbing spurs or spike shoes for climbing palm trees is prohibited. The Contractor shall be required to use an aerial tower with sufficient height to reach the crown for pruning palm trees.
- All palm tree crowns shall be cut at 10/2 appearance removal of loose dead fronds, fruit clusters, and other vegetation from all palms.
- Palm de-booting skinning Dead fronds, and parts thereof, including stubs, shall be removed along the entire length of the trunk of each palm, leaving a clean unsheathed appearance slicked from the ground to approximately thirty-six (36") inches from the base of the green fronds at the top of the palms crown, The frond stubs (cut close to trunk) can be left in place within a span of at least (30") inches but no greater than thirty-six (36") inches from the base of the green fronds at the top of the tree.
- The objective of pruning palms is to remove dead and contagious-diseased fronds to eliminate the risk of dead fronds falling while retaining a 10 / 2 frond crown and a healthy plant as possible.
- Debris shall be removed from the property same day.
- Bidders will be required to carefully review the scope of work referenced above and visit the site location of the proposed work to judge and evaluate for themselves as to the nature of work to be done, and the general conditions relative there also.
- The Contractor shall ensure that a **certified arborist**, as accredited by the International Society of Arboriculture oversees the tree work according to these specifications.
- The submission of a proposal shall be considered evidence that the bidder has made the necessary investigations and is satisfied concerning the conditions encountered, the character, and the quantity of the work to be performed. The Contractor is advised to visit the project site before submission of the bid.

GENERAL REQUIREMENTS

- A) certified arborist must be an employee of the company performing a project
- B) Proper disposal of all tree debris, Spoils generated is the reasonability of the contractor and must be removed by the end of each working day.
- C). Assuring adequate safety of employees and the public Prior to starting any work on a JHA tree.

D) Work time: 8:00 am to 4:30 pm normal working hours, other times shall be discussed, and any clarification addressed by Jacksonville Housing Authority Property Manager
