- B. Offerors are hereby notified that they shall make any necessary adjustment in their estimates on account of this Addendum. It will be construed that each Bidder's documentation is submitted with full knowledge of all modifications and supplemental data specified herein.

Addendum #1

- 1. The deadline for this RFP has been extended to Monday, May 15, 2017 at 3:00pm ET.
- 2. Regarding item #1, please quote both a soft cab and a hard cab (weather control), and a hydrostat transmission.
- 3. Regarding trailers (#11, #12) they should be quoted with a ramp. They should be single axle.
- 4. On item # 5, Grasshopper is one of the approved brands. It is acceptable to propose an "or equal".
- 5. On item # 5, please bid both a manually folding deck, and a power fold option. Also please bid with turf tires.
- 6. On the Zero turn mowers, (#3 & #4), please bid as front mount as we may want to add attachments at some point.
- 7. It is acceptable to provide prices for only the items that you are comfortable furnishing. We may elect to have multiple contracts if it is LMHA's best interest to do so.
- 8. We are expecting our contractor/vendor to ensure that the "or equal" test is met when proposing alternate brands of equipment.
- 9. The push mowers require an electric start.
- 10. Please identify the grade of product if it is different than what is on our specifications. If we are calling out a "consumer series product" and you are bidding a "commercial" option with a warranty that is different than one year, it should be stated on your proposal. Please attach



additional sheets as needed.

11. Technical data sheets are required for the equipment as outlined in the RFP.
