NOTICE TO PROPOSERS:

- A. This Addendum shall be considered part of the Contract Documents for the above mentioned project as though it had been issued at the same time and shall be incorporated integrally therewith. Where provisions of the following supplementary data differ from those of the original Contract Documents, this Addendum shall govern and take precedence.
- B. Offerors are hereby notified that they shall make any necessary adjustment in their estimates on account of this Addendum. It will be construed that each Bidder's documentation is submitted with full knowledge of all modifications and supplemental data specified herein.

Addendum #1

- 1. The deadline for the proposal is now due on October 25, 2017 at 3:00 pm ET.
- 2. There is no requirement for a Bid Bond.
- 3. There is no requirement for a prevailing wage.
- 4. The vehicle cost that is listed as equipment is to be part of the hourly wage.
- 5. We would prefer that the roving guard be a foot patrol. The vehicle may be used if a guard is handling sites that are within a reasonable distance of each other.
- 6. We do not require that the guards have specialized training such as CPR. We have no AED (automated external defibrillators) equipment.
- 7. There is no secondary use of force for the unarmed guards.
- 8. The current hours for unarmed guards vary per site but the average is Wednesday Sunday from 6:00 pm to 2:00 am.
- 9. The suggested hours for armed guards currently is from 6:00 pm to 2:00 am but is subject to change.
