- 2. All questions must be submitted in writing to the Authority no later than <u>12:00 pm ET, on May 25,</u> <u>2017.</u>
- 3. Windows: Can Paradigm Windows & Doors Be Used As An Alternate?

Response: It is important to us to maintain a uniform exterior appearance (e.g. Frame profile, glazing placement, color, muntin pattern, and warranty). Given the short time frame, we would strongly recommend pricing the specified products for bidding purposes. We can more thoroughly compare possible alternatives prior to the start of work.

4. Vinyl Flooring: Can Arrmstrong Luxe Vinyl Plank Flooring Be Used As An Alternate?

Response: Armstrong Luxe Vinyl Plank Flooring will be considered as an equal to the specified product. System to be of the type where tiles are bonded to the adjacent tiles (floating type floor), not to the substrate.

5. Cabinet Hardware: Can you provide a spec for cabinet hardware?

Response: Manufacturers standard Soft Close hinges and drawer glides. Contractor should provide an allowance of \$35.00 for cabinet door and drawer pulls.



6. Bathtub Surround: Can you provide more details for tub surround material?

Response: Bathtub surround to be KOHLER Choreograph White Shower Wall Surround Side and Back Panels with soap/shampoo shelves as indicated on Drawings, or approved equal.

7. Toilet: Are you providing toilet bowl or just toilet tank?

Response: Both toilet bowl and tank will be provided.
