- B. Offerors are hereby notified that they shall make any necessary adjustment in their estimates on account of this Addendum. It will be construed that each Bidder's documentation is submitted with full knowledge of all modifications and supplemental data specified herein.

- Attached are maps, addresses, and estimates of the amount of cy of debris, cf of concrete to be removed, and cy of topsoil needed. Please note that the maps have green (phase 1) and yellow (phase 2) locations. Phasing may be done at the direction The maps were obtained from google earth. Note that there may be 2 addresses for a double shed (1 shed is shared by 2 houses).
- 2. Please complete and return the Non-Collusive Affidavit with your sealed bid.
- 3. Please return the following documents with your sealed bid:

Bid Form (signed), Table of Contents (signed); Bid Bond if applicable (signed & notarized); Bid Breakdown by division (or category of work); subcontractor listing (if applicable); HUD 5369-A (completed & signed); Contractor / Vendor Qualification Statement (completed & signed); Section 3 documents (completed & signed); Non-Collusive Affidavit (completed & notarized)

4. If your bid is over \$50,000, pursuant to the HUD 5369 #10, please see the acceptable methods of furnishing an Assurance of Completion below:

10. Assurance of Completion

(a) Unless otherwise provided in State law, the successful bidder shall furnish an assurance of completion prior to the execution of any contract under this solicitation. This assurance may be [Contracting Officer check applicable items] —



- [X] (1) a performance and payment bond in a penal sum of 100 percent of the contract price; or, as may be required or permitted by State law;
- [] (2) separate performance and payment bonds, each for 50 percent or more of the contract price;
- [X] (3) a 20 percent cash escrow;
- [X] (4) a 25 percent irrevocable letter of credit; or,
- [] (5) an irrevocable letter of credit for 10 percent of the total contract price with a monitoring and disbursements agreement with the IHA (applicable only to contracts awarded by an IHA under the Indian Housing Program).
- (b) Bonds must be obtained from guarantee or surety companies acceptable to the U.S. Government and authorized to do business in the state where the work is to be performed. Individual sureties will not be considered. U.S. Treasury Circular Number 570, published annually in the Federal Register, lists companies approved to act as sureties on bonds securing Government contracts, the maximum underwriting limits on each contract bonded, and the States in which the company is licensed to do business. Use of companies listed in this circular is mandatory. Copies of the circular may be downloaded on the U.S. Department of Treasury website http://www.fms.treas.gov/c570/index.html, or ordered for a minimum fee by contacting the Government Printing Office at (202) 512-2168.
- 5. Regarding Section 3 documents, all bidders must complete and sign Form #1 Section 3 Clause Acknowledgement.

In addition to the above form:

If you will <u>not be hiring any people for this job</u>, and will not be hiring a subcontractor, then complete Form #3, Part 1, Part II and initial the boxes on Part III, and sign and notarize page 7.

If you are <u>subcontracting</u> for the job, complete Form #3, Part I, Part II, Part IV, and sign and notarize page 7.

If you are <u>hiring</u> for the job, complete Form #3, Part I, Part II, Part V, Part VI, and sign notarize page 7. If you are a <u>Section 3 Business</u>, complete Form #2, and sign. If you are not hiring, then complete the documents as listed above.


