In lieu of Marvin Sliding Patio Door w/ ADA sill as specified in (Sec. 083219) Sliding Wood-Framed Glass Doors provide Marvin Ultimate Swing Patio Door 6068-OXR (field verify) with ADA sill, or Owner/Architect approved equal.

Doors to include manufacturer's standard insulated low-E glazing, hardware, insect screen, and accessories. Exterior finish to be standard fluoropolymer two coat system and standard interior painted wood finish. Door installer must provide units that are ADA/UFAS compliant 32" clear egress width.
