## LANDLORD FEEDER CONDUCTORS

Copper conductors shall be installed in feeder conduits from the utility transformer supplying main switchgear and panelboard 'HP'. Copper conductors shall be installed in all feeder conduits supplying landlord panelboards, including secondary panelboards. Copper conductors shall be installed in feeder conduits supplying all tenant meter centers.

## **TENANT FEEDER CONDUCTORS**

Non-metallic cabling shall be used to supply tenant panelboard from meter center tenant circuit breaker. (Option: Aluminum cabling may be substituted for copper but must be sized properly per NEC).

### **TENANT BRANCH CONDUCTORS**

Non-metallic copper cabling (AKA: Romex) shall be used from tenant panelboard to individual branch circuits within tenant space, including condensing units.
